6. Refund Policy 2027-28

For any discount availed at the time of admission and requesting for a refund, the discount stands cancelled and the refund policy will be applicable as follows:

7. General Notes

- The food facility is optional only for Pre-Primary children and mandatory for all students from Grade 1 onwards.
- As per the school's policy, parents are liable to pay the food fees for all students from Grade 1 onwards, with no exceptions in this regard.
- Parents who wish to enroll their child for the food facility (Pre-Primary only) must confirm their choice at the time of admission or fee payment.
- Once the food fees are paid, the fee structure will not change even if the parent wishes to opt out later.
- The 1st installment of fees is due on 5th April of every academic year, and the 2nd installment is due on 5th September.
- Provisional admission fees must be paid at the time of admission. On confirmation of admission, the remaining fees must be paid within 7 working days from the date of provisional admission.
- There will be a minimum 7.5% annual increment on the total fee structure for the following academic year.
- Supplies and books will be charged on actuals and must be paid during admission. Please note that this amount is non-refundable.
- A one-time full fee payment will be eligible for a 5% discount on the overall fee.
- A sibling discount of 10% is applicable only on tuition fees and only for the second child.
- All fees once paid are non-refundable and non-transferable under any circumstances.
- Optional facilities such as daycare, transportation, and after-school activities will be charged separately and are not included in the fee structure.
- The school reserves the right to revise optional facility charges annually with prior notification to parents.

8. Tuition Fee

This fee includes expenses relating to Academics and beyond academics. Examination/Special needs/assessment fee associated with the Board of Education or other external exams and Third-party service providers (for ex: Sports day costume or Annual day costume) and technology fees are NOT included in the above Academic fee and will be charged as and when due.

9. Books, Uniforms & Shoes

Books, Uniform & Shoes will be supplied by outside vendors and these expenses are payable directly to the vendors.

10. Food Service / Bus Fee

The bus service includes pick up and drop of students from/at designated centralised locations. This is not a DOOR-to-DOOR service. This also covers transport expenses for inter-school events and field trips within Bangalore (whenever it is feasible to use our school buses).

Please note that the School Meal cost will be CHARGED ONCE A YEAR as part of the school fee and the transportation fees will be CHARGED THRICE A YEAR, IN THREE INSTALLMENTS, and cannot be withdrawn in the middle of the payment schedule. Additionally, if the school is forced to close due to unforeseen circumstances, these fees will not be refunded or adjusted for any unused days in already commenced payment schedules.

11. Important

Payment of fee will constitute acceptance of the applicable Fee Policy including all the terms and conditions stated therein.
